Director Sharkey had the privilege to work at Fleet's PM Truck Repair Shop during a recent Director Day. A "PM" or preventive maintenance is when a vehicle is brought in, repaired, and checked proactively. A long standardized checklist is examined allowing small problems to be addressed before they become larger problems.

DGS was having trouble completing truck PMs in a prompt and efficient manner. To combat this, DGS created a select PM shop, staffed by a group of 5 employees dedicated to completing PMs. Each day, these employees perform PMs on load packers, dump trucks, and water trucks.

Keeping these trucks moving and reliable is important work, as is all the work that DGS employees do. The Director worked primarily with seasoned veteran Bill Amberman as well as Damon Johnson, a new employee who previously worked at the Bureau of Solid Waste while going to school at night learning to become a mechanic.

MITCHELL COURTHOUSE FIRE:

FACILITIES MAINTENANCE RESPONDS

The DGS Facilities Maintenance Division has worked long hours since a recent fire broke out in the Mitchell Courthouse on April 26th.

The fire started in the basement area just below the Fayette St. entrance. The cause of the fire was found to be a fault on the transformer in the basement.

The restoration contractors started to work around the clock in order to start clean up of the most heavily impacted areas to remove the heaviest of soot. These teams have continued to work 12 to 16 hour shifts, 7 days a week in order to restore the building.

DGS teams have been active in the building replacing dozens of ballasts and nearly one hundred light bulbs.


The website also has a Job Notification section that sends reminders once positions are posted with application deadlines.

DGS Strategically Manages the City's Real Estate Portfolio





DGS actively monitors space utilization and has assertively moved agencies into vacant office space. In cases where the City did not designate a specific use, DGS continues to divest so that the property can be put on the tax roll. This approach is a component of Department's plan to strategically manage the City's Real Estate portfolio supported by the creation of the Facilities Maintenance System (FMS) database, VFA, and Archibus systems.

As an example, 3314 Arydale Avenue was deemed a surplus property by DGS because the building was underused and no longer provided a public purpose. The property, purchased by Williams-Carroll, LLC for \$35,127, operates as a hair salon business. The property is now listed on the tax roll which benefits the residents of Baltimore.

CLARA BARTON EXHIBIT AT THE WAR MEMORIAL

The War Memorial Building is a historical treasure honoring our state's military veterans. During the past 3 years DGS has hosted special exhibits to further commemorate our nation's history. From April 5th – June 5th the War Memorial has on display a 3 panel exhibit featuring Clara Barton's Missing Soldiers Office.

The staff of the Missing Soldiers Office made it their mission to find information about the location, or death, of missing soldiers in order to provide closure to their family and friends. The office responded to over 63,000 letters of correspondence and identified the fates of more than 22,000 missing soldiers. The War Memorial, located at 101 North Gay Street, Baltimore, MD, honors and serves all veterans of Maryland. The building serves as a place of remembrance for fallen soldiers and as administrative offices for several veterans' outreach organizations. The War Memorial Commission has custody and supervision of the War Memorial Building and the adjacent War Memorial Plaza which fronts City Hall.

The space is utilized for certain municipal functions and also serves as a repository for documents pertaining to the events of World War II. An exhibit space is also located on the premises. The building is a Baltimore City Landmark and a major component of the National Register Business and Government Historic District.
